Once the application form is submitted, sponsor agrees to all rules and regulations set forth here.

CONFLICTING MEETINGS & SOCIAL EVENTS - The sponsor agrees not to extend invitations, call meetings, or otherwise encourage absence of conference participants during conference plenary sessions.

CANCELLATIONS - No refunds will be issued for cancellations by sponsors after March 30. Cancellations received before March 30 will receive a 50% refund of the sponsor fee. An exception is made if the 2025 Hawaii Energy Conference (HEC) changes format to wholly virtual, for any reason -- sponsors will have the option to carry over the sponsorship until the ensuing HEC or request a full refund. Cancellations of agreements should be sent to info@hawaiienergyconference.com and will be effective upon receipt of confirmation email.

COMPLIANCE WITH LAWS - Sponsors must comply with all federal, state, and local laws, including health and safety codes, alcoholic beverage control laws, disability laws, and the like.
